- Percentage giving. Through your will, you can designate percentages of your estate as you see fit. For example, designate 5% of your total estate to Lincoln Park Zoo, while leaving 95% to loved ones.
- **Blended giving.** Give an outright gift of cash or other assets today, combined with a future gift, such as naming the zoo in your will.
- **Beneficiary designation**. A simple form is all it takes to name the zoo as a beneficiary of your retirement plan assets, unneeded life insurance policy or donor-advised fund.

Choosing to include a charitable gift in your estate plan is no exception. For peace of mind, it helps to talk to these critical "team members" as part of the process.

You likely have loved ones whose input you value. And you may want to provide for them after your lifetime. Balancing that with a desire to help our mission in the future is easier than you may think, thanks to percentage giving.

# IMPORTANT YEAR-END CONSIDERATIONS

## It's Just as Great to Give as to Receive

We know that your decision to support Lincoln Park Zoo comes from the heart. An added bonus is that your gift may also qualify for a tax break this year when you itemize deductions on your federal income tax return.

## Assets You Didn't Know You Had

Here are some assets you may not have considered and the impact they can have on your taxes when you use them charitably.

#### **IRA Distribution**

- If you are 59.5 years or older, you can take a distribution from your IRA and then make a gift to Lincoln Park Zoo without penalty. If you itemize your deductions, you can take a charitable deduction for the amount.
- If you are 70.5 years or older, you can give any amount up to \$100,000 per year from your IRA directly to Lincoln Park Zoo. You will not pay income taxes on the transfer.
   If you are 72 or older, you can use this transfer to satisfy your required minimum distribution.

**To do:** We must receive your gift by Dec. 31 for your donation to qualify this year. If you have check-writing privileges on your IRA, please be sure to mail your check early in the month to allow time to process your gift.

## **Appreciated Stock**

You may enjoy two tax benefits with a gift of appreciated stock: Avoid paying taxes on the appreciated value, and qualify for an income tax charitable deduction based on today's market value when you itemize.

**To do:** Complete all transfers by Dec. 31. This includes electronic transfer, hand-delivery of the securities or mailed stock and stock power (mailed separately for security).

#### **Donor-Advised Fund**

Contribute to a donor-advised fund and enjoy a tax savings on that amount when you itemize.

**To do:** Complete the contribution by Dec. 31. You do not have to designate the funds this calendar year to receive the tax benefits.
